GAC Treasurer's Report for the Financial Months Ending November 30th and December 31st, 2023

Greetings, Unit Owners, Nicole, and fellow Board Members:

I am reporting to you this evening, financial summary highlights for the months of November and December 2023. You can find full financial summary data for November and December 2023 posted on TownSq.

November:

Cash for Operations: \$27,559.62 Reserve Funds: \$198,704.55 CF: \$115,450.12 WP: \$265.61 WP CD: \$82,988.82 Net Income: \$47,903.82 Operating Net: (\$4,477.61) Reserve Net: \$52,381.43

December:

Cash for Operations: \$30,490.87 Reserve Funds: \$199,550.82 CF: \$115,940.39 WP: \$265.67 WP CD: \$83,344.76 Net Income: \$60,120.82 Operating Net: (\$116.88) Reserve Net: \$60,237.70

To end the 2023 financial year with either a very small Operating Net Income or Loss, it turns out it was not necessary to withhold the December reserve contribution of \$7,010.00. That contribution was made right at the end of December and posted in our CF Bank Account in early January. As a result, we ended the year with a very small Net Operating Loss of \$116.88.

Jerry Geswein (our current insurance broker) has provided us with quotes from 3 different insurance companies, as the company we are presently using (Great American) is no longer offering insurance coverage for condominiums, going forward. Nikki has contacted Jason Glover (a broker from Bowers Insurance Services Agency), who has provided us with a quote from a different insurance company. We will be comparing the pros and cons of cost and coverage of the insurance companies and come to a decision soon.

In preparation for filing our 2023 federal tax return (Associa uses the services of Devin & Associates), I have received a 1099-INT from Wright-Patterson Credit Union. I am awaiting a 1099-INT from CF Bank, before I forward copies from both of our Reserve Accounts to Associa for purposes of filing.
