Get to know your neighbors in the Glen through this feature, we call "The Glen 10". Ten questions and answers with a Glen Abby resident. This issue features your newletter editors, Jim and Linda Pace who live at 6251 Abby Gate Court.

- **1. How long have you been a resident?** We closed on our condo on Sept. 30, 2014, but didn't move in until Nov. 5. We have lived here five months.
- 2. What brought you to this community? We were looking for a smaller home with a main floor master suite and laundry. We liked the floor plan at Glenabby. It seemed to fit our life style and we loved the sun-room. Not shoveling snow or taking care of grass was appealing to Jim, especially after the winter of 2013-14. Residents, Becky and Dave Smith, talked with us when we were condo looking and they were

friendly and positive about the community. The woods next to the condo was also appealing.

- **3. Where did you move from?** We came from Forest Park in Columbus where we lived for 43 years in three different homes, all within 5 blocks of one another. We last moved in 1986!
- 4. Are you a native Buckeye or were you born somewhere else? What states have you lived in before coming to Glenabby? We have lived in Ohio forever. Jim is from Cleveland and Linda from Cincinnati. We have lived in Columbus since we were married in 1971.
